# Top 3 Political Stories This Week

- EU sources expect UK to have to accept a 'Norway-style' transition period
- US Government shuts down for 3 days with only an agreement to vote on DACA ending impasse
- SPD begins formal Grand Coalition talks after SPD conference votes 363-279 in favour

## BlondeMoney View

- In his visit, France Pres Macron suggested there are 2 options for the UK post-Brexit: Norway or Canada. The former would unsurprisingly split May's Cabinet down the middle; Remainers in favour, with Brexiteers like BoJo already briefing that it would be better to stay in the EU rather than choose the Norway option and become a 'vassal state'. But could Norway fit the transition period? That's the view of MEPs: "It has to be a Norwegian-style deal, it cannot be anything else and this has been agreed in principle... I heard no one disputing this from the UK's side." They may have misunderstood the UK's silence as agreement, when in fact the UK is still undergoing a negotiation with itself. Good Luck selling the Norway path to 52% who voted to Take Back Control.
- Although short term funding has been agreed until Feb 8<sup>th</sup>, both parties remain diametrically opposed on issues such as immigration and spending budgets. The agreement to have a debate about immigration is significantly scant on detail and there is the possibility of another shutdown after the Feb 8<sup>th</sup> deadline. Trump will now want to move onto putting America First by appearing at the elite's Davos jamboree just as new <u>trade tariffs</u> are put into place.
- Polls suggest 52% of voters are 'very unhappy' or 'unhappy' about the prospect of another Merkel/ Schulz alliance. This allies with 56% of the SPD itself voting to support another 'GroKo'. This vote was taken in public at the weekend conference, in front of the Party leader. Now though the vote moves onto the SPD membership in a secret ballot. Suddenly, the party is receiving a surge of membership applications, suggesting the youth wing call for "no more 'more of the same'" is gaining momentum. "Stop the Grand Coalition for a tenner" runs the campaign, and 600 new members signed up in North Rhine-Westphalia in 36 hours, versus a typical 4,000 in a year. Meanwhile a Bundestag document now suggests that, as tradition usually dictates, the opposition party would chair the Budget Committee, giving the anti-Euro AfD unprecedented power. Merkel is trying to assert herself, putting out a joint video with France's Macron over the future of Europe. But behind the scenes her party are preparing a Plan B: a six month minority government before fresh elections. It ain't over til it's over.


